



**- CONTINUING EDUCATION REQUIREMENTS -**

**CURRENT SALESPERSONS' 2 YR. RENEWAL PERIOD - 05/01/09 thru 04/30/11**

**FOR NEW LICENSEES:**

**If you've been licensed less than two years, your continuing education hours are determined by the date of issuance through the Illinois Dept. of Financial & Professional Regulations (IDFPR). To determine that date, please go to the following link and follow the path.**

1. If a licensee receives their initial sales license between 05/01/2010 -04/30/2011, they are exempt from c.e.
2. If a licensee receives their initial license between 05/01/09 - 04/30/2010, they will need 6 hours of C.E. (3 hrs. CORE of CORE A or B is required; the remaining 3 hrs. can be CORE or Elective).
3. If you **renewed your Sales license with IDFPR** for the last renewal period ending 04/30/09, you will need 12 hours of c.e. by 04/30/2011 (3 hrs. of CORE A; 3 hrs. of CORE B and 6 hrs. of Elective).

**CURRENT BROKERS' 2 YR. RENEWAL PERIOD - 05/01/08 thru 04/30/10**

1. If you are licensed as a Broker AND NOT PREVIOUSLY LICENSED AS A SALESPERSON, between 05/01/2009 - 04/30/2010, you will need the 6 hr. Broker Management course due within 180 days of licensure.
2. If you are Licensed as a Broker AND NOT PREVIOUSLY LICENSED AS A SALESPERSON, between 05/01/08 - 04/30/09, you will need 12 hours of C.E. (6 hrs. Brokerage Management course, 3 hrs. of CORE A or B; and the remaining 3 hrs. can be CORE or Elective).
3. Brokers, PREVIOUSLY LICENSED AS A SALESPERSON, will need 18 hours of C.E. by 04/30/2010 (6 hrs. Brokerage Management course, (3 hrs. of CORE A; 3 hrs. of CORE B and 6 hrs. Elective).
4. If you **mailed your Brokers' renewal form to IDFPR** for the last renewal period ending 04/30/08, you will need 18 hours of c.e. by 04/30/2010 (6 hrs. Brokerage Management course, (3 hrs. of CORE A; 3 hrs. of CORE B and 6 hrs. Elective).
