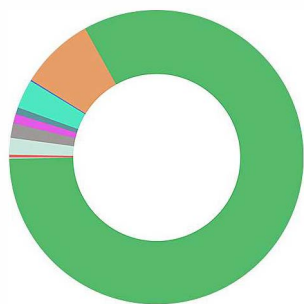

## **AFFILIATE MEMBER CODE OF CONDUCT 2025**

As an Affiliate Member of Mainstreet Organization of REALTORS®, I will abide by the "Affiliate Member Code of Conduct." I pledge to demonstrate to REALTORS® and Affiliates that I am a professional and strive to do my best in serving my clients.

An Affiliate Member shall not deny equal professional services or shall not be party to any plan or agreement to discriminate against any person on account of race, age, color, religion, sex, ancestry, order of protection status, gender identity, marital status, physical or mental disability, familial status, national origin, sexual orientation, military status, dishonorable discharge from the military service, or any other class protected by the Illinois Human Rights Act.

An Affiliate Member shall not disparage competitors or other Affiliates for any reason. An Affiliate Member shall not knowingly or recklessly make or publish false or misleading statements about competitors or Mainstreet Members, whether or not such statements are intended to gain unfair advantage over competitors.

An Affiliate Member is required to use professional courtesy and consideration at all Mainstreet events in which you are not a paid sponsor, including, but not limited to, refraining from actively marketing their business, distributing marketing materials or business cards, or otherwise encroaching on the benefits allotted to paid sponsors, except as may be specifically permitted by Mainstreet.

An Affiliate Member shall be informed and do business in accordance with all laws, governmental regulations, and public policies, if any, in the field in which the Affiliate Member customarily engages. Affiliate Members shall maintain proper insurance and licensure(s), where applicable.

An Affiliate Member shall provide a level of proficient service in keeping with the standards of practice in the field in which the Affiliate Member customarily engages.

An Affiliate Member should adhere to the CAN-SPAM act when using a Mainstreet member list provided to them through a sponsorship opportunity.

An Affiliate Member shall not undertake activities that compromise or interfere with the contractual business relationship which REALTOR® and Affiliate Members may have with their customers and clients.

An Affiliate Member shall abide by the bylaws of the association.

Violation of the Affiliate Code of Conduct will result in one or more of the following actions, in the exercise of the reasonable discretion of the Board of Directors of the Mainstreet Organization of REALTORS®:

- Written warning;
- Revocation, for a period not to exceed six (6) months, of the right to attend or to sponsor Mainstreet events;
- Termination of affiliate membership without refund of individual or corporate affiliate membership dues

Any Affiliate member accused of a violation of the Affiliate Code of Conduct shall have the following rights:

- The right to receive a copy of the full complaint, including the name of the complainant;
- The opportunity to respond in writing to the complainant;
- The opportunity to present evidence in the presence of the Complainant and to cross-examine the Complainant during a hearing with the Executive Committee, Board of Directors, or a panel thereof.

The undersigned acknowledges the intention to abide by the Mainstreet Organization of REALTORS® Affiliate Code of Conduct and further acknowledges that violations of the Code of Conduct may provide for such disciplinary actions described above.
